Town of Between Council Minutes

October 12, 2021

- **Call to Order** - Mayor Post called the meeting to order at 7:00 pm and led the Pledge of Allegiance
- **Roll Call** Present: Robert Post, Wanda Satterwhite, Jeanne Sullivan and Mary Ann Rivers
- **Approval of Previous Meeting Minutes** - Motion was made by Wanda Satterwhite to approve September 15, 2021 minutes and Jeannie Sullivan, seconded the motion. The minutes were approved and recorded.
- **Approval of Financial Reports** - Motion was made by Mary Ann Rivers to approve the October 15, 2021, financial reports and Jeannie Sullivan seconded the motion. The financial reports were unanimously approved and recorded.

Updates

- The RFP for the new Town Hall has been advertised in the Walton Tribune on October 10, 2021 and again on October 13, 2021. It has also been posted on the Georgia Procurement Registry. Bid packages are due back on November 5, 2021. After the bids are reviewed for compliance, the council will grade the responses and select a contractor.
- North New Hope Church Road paving project is still waiting on the company to complete the striping of New Hope Church Road. According to the county public works department, they had been delayed due to all the rainy weather.
- Saint Martin Estates Paving Project will begin on Monday, October 11, 2021 weather permitting. Walton County Public Works Department has moved their equipment into Saint Martin. They have swept the streets. Cleared debris from curbs and sprayed weed/grass killer along the joints between the concrete curb and the asphalt. It is anticipated that the paving will take 4 days.
- November 2nd Municipal Election – The Chamber of Commerce held a candidates' forum recently. Between council candidates Brian Rubin, Jonathan Page and William (Bill) Boswell participated.

Old Business

The second reading of the Ordinance Providing for the Licensure and Sale of Malt Beverages and Wine within the jurisdiction of the Town of Between was held. A motion to approve was made by Wanda Satterwhite and seconded by Jeannie Sullivan. The motion was approved and recorded.
