## **Town of Between Council Minutes**

**December 14, 2021**

- **Call to Order** - Mayor Post called the meeting to order at 7:00 pm and led the Pledge of Allegiance
- **Roll Call:** Present - Robert Post, Wanda Satterwhite, Jeanne Sullivan and Mary Ann Rivers
- **Approval of Previous Meeting Minutes** - Motion was made by Jeanne Sullivan to approve the minutes for the November 9, 2021 meeting and Wanda Satterwhite seconded the motion. The minutes were approved and recorded.
- **Approval of Financial Reports** - Motion was made Jeanne Sullivan to approve the financial reports for December 2021 and Wanda Satterwhite seconded the motion. The financial reports were unanimously approved and recorded.

### **Updates**

- **New Town Hall Project** - As a result of the bids for the new building being over the allocated funds, the council voted last month to reject all bids. Mayor Post has been discussing option #2 (renovation or demolition of the current building) with several residential contractors about the project. A new bid proposal will be completed after the first of the year.
- **Walton County and Municipalities Comprehensive Plan** - The Northeast Georgia Regional Commission will be conducting a third ZOOM on January 5, 2022. This meeting will be to discuss public infrastructure and services.
- **Municipal Election Swearing -In** - At the January 11, 2022 Council Meeting, Mayor Post and Council members Mary Ann Rivers, Brian Rubin, and William Boswell will be sworn in to office.

### **Old Business**

- **Annexation and Rezoning Request** - Mayor Post received an annexation and rezoning request from Rosewood Development for the property they are developing on Highway 78 West adjacent to the Baptist Church. A portion of the property is currently in Between town limits. They are requesting annexation into the Town of Between for the remaining property and rezoning the property from B2 to PBD. The request will be considered by the Council at the January, 2022 Council meeting.
- Pads for the Pickleball courts have been poured near the Splash Park.

### **New Business**

- **FY 2022 Operating Budget** - Mayor Post read the Budget Resolution for the FY 2022 Operating Budget which is required by the State of Georgia. The FY 2022 Budget was presented. Wanda Satterwhite made a motion to approve the resolution and budget and Jeanne Sullivan seconded. The resolution and budget were unanimously approved.
- **Special Presentation** - Mayor Post presented Jeanne Sullivan with a plaque recognizing her years of service and commitment to the Town of Between.
- Wanda Satterwhite made a motion to adjourn the meeting and Jeannie Sullivan seconded. The meeting was adjourned at 7:50 pm.
