February 11, 2025

### Call to Order

- Mayor Post called the meeting to order at 6:00pm and led the Pledge of Allegiance.

### Roll Call

- Mayor Robert Post, Vice Mayor Wanda Satterwhite, Council member Bill Boswell, Council member Debra Artz, and Council member Steven Koehlke were present. All council members were present.

### Mayor & Council Agenda

- Approval of Minutes – January 14, 2025 Meeting
  - Council member Bill Boswell made the motion to Approve the January 14, 2025 minutes and Vice Mayor Wanda Satterwhite seconded the motion to Approve. The Minutes were unanimously Approved and Recorded.
- Approval of Treasurer's Reports – February 2025
  - Council member Debra Artz made the motion to Approve the February Treasurer's report and Council member Bill Boswell seconded the motion to Approve. The January Treasurer's report was unanimously Approved and Recorded.

### New Business

- **2025 LMIG Grant**
  - The 2025 Local Maintenance Improvement Grant (LMIG) has been approved for \$7,766.62. It was deposited into our General Fund account on February 4, 2025. These funds, combined with our General and SPLOST funds pay for paving projects within the town jurisdiction. The Board has allocated Royal Park Drive to be repaved after construction is completed on new business building is completed.

- **2025 General Election**
  - The General Election will be held on November 4, 2025. As required by state law the qualifying fees were published in the Walton Tribune on February 1, 2025. The qualifying period will run from August 18, 2025 (8:30 am) until August 20, 2025 (4:30pm). This year there are two (2) council positions open as well as the mayor position. Qualifying packages can be picked up at 3020 Sweetwater Trail, Monroe, Georgia 30656 on the date and time listed above. The completed packages with the qualifying fees, must be returned to the same address no later than 4:30 pm on the date listed. The qualifying fee for council the qualifying fee for council members are \$72.00 and for mayor is \$144.00.
- **Monument Sign Upgrades**
  - The work on extending the brick columns needed to mount the LED message boards has been completed. The columns will be painted by the sign company. Installation of the message boards should be completed by the end of the month.
- **Walton EMA Hazardous Mitigation Plan Update**
  - The Walton County Emergency Management Agency will be conducting meetings on February 18th and March 18th for the purpose of updating the Walton County Hazardous Mitigation Plan. The plan is required to be updated every five years by the Georgia Emergency Management Agency. The meeting will be held at the Walton County Government Building in Monroe, Georgia. Mayor Post will be attending as the representative for the Town of Between.
- **Walton EMC Refund**
  - Mr. Kelvin Smith from Walton EMC presented Mayor Post with a \$25,138.00 check from 2024 Capital Credits. Walton EMC returned 9 million dollars for 2024.
- **Website update**

- **Town Hall Rental Update**
